- **Classification:**
 - Acute Toxicity, Inhalation (Category 4)

- **Barium Sulfate (CAS 7727-43-7):** 25–30%
- **TGIC (CAS 2451-62-9):** 1–10%

SECTION 4: FIRST-AID MEASURES
